The City Government of San Fernando, Pampanga, through the Approved Budget 2014 intends to apply the sum of **ONE MILLION TWO HUNDRED SEVENTY FIVE THOUSAND PESOS ONLY (P1,275,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **ES-J3-14-0894**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The City Government of San Fernando, Pampanga now invites bids for the **Supply and Delivery of 150 pails Disinfectant/Deodorizer to be used for the Rehabilitation of the City Transfer Station in the City of San Fernando, Pampanga**. Delivery of Goods is required to ten (10) days upon receipt of the contract. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

The City Government of San Fernando, Pampanga will hold a Pre-Bid Conference on **APRIL 23, 2014 (WEDNESDAY) 10:30 a.m. at CGSO Building, New Public Market, Del Pilar, City of San Fernando, Pampanga**, which shall be open only to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below on or before **10:00 a.m. of MAY 07, 2014 (WEDNESDAY) at CGSO Building, New Public Market, Del Pilar, City of San Fernando, Pampanga**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in Instruction to Bidders (ITB) Clause 18.

Bid opening shall be on **MAY 07, 2014 (WEDNESDAY) 10:30 a.m. at CGSO Building, New Public Market, Del Pilar, City of San Fernando, Pampanga** will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
