

EXECUTIVE ORDER NO. CMO2013 - 018

AN ORDER RECONSTITUTING THE COMPOSITION OF THE MULTI SECTORAL GOVERNANCE COUNCIL (MSGC)

WHEREAS, the Multi Sectoral Governance Council (MSGC) was created by virtue of an Executive Order No. CMO2006-004 appointing its members and specifying its duties and functions;

WHEREAS, the MSGC was created for the purpose of realizing benefits for the common good of all residents of the City and establish a shared goal with distributed responsibilities between the government and the governed, among public officials, the ordinary citizens and the various sectors of the society all committed to their shared goals and responsibilities;

WHEREAS, the MSGC consists of member organizations representing the different sectors of the society from which the standing committees were also created for purposes of undertaking deliberations on proposed measures for recommendation to the Local Chief Executive and the SangguniangPanlungsod;

WHEREAS, in line with the change of administration in the local government unit, the composition of the MSGC should be reconstituted;

NOW, THEREFORE, I, EDWIN D. SANTIAGO, Mayor of the City of San Fernando, Pampanga, by virtue of the powers vested in me by law and the constitution, hereby order as follows:

Section 2

Structure and Composition of Sectoral Committees

1. The MSGC shall consist of six (6) standing committees:
 - Education, Culture Preservation and Sports Committee
 - Health Committee
 - Trade, Industry and Economic Development (TIED) Committee
 - Transportation, Communication and Infrastructure (TransComInfra) Committee
 - Public Safety and Order Committee
 - Environmental Management Committee
2. A standing committee may be composed of members representing various sectors that are involved in the particular policy area.
3. The Council may appoint the chair of the committees or the members of the committee may choose their chair.
4. Membership in committees is best determined based on the expertise and interests of the sectoral representatives.
5. Membership in committees may be limited to a certain number to allow members to attend to their committee duties in an efficient manner, e.g. a member is allowed to chair no more than two standing committees, or to be a member of no more than three standing committees.

Section 3

Composition of the Membership Committee

The members of the Membership Committee shall be duly elected by the Council members. The Council may appoint the chair of the committee of the members of the committee may choose their chair.

Section 4

Within a reasonable period after the issuance of this Executive Order, a notice of the need to immediately convene the Multi Sectoral Governance Council shall be disseminated to all aforestated member organizations thereof.
