#### I.BACKGROUND

Pursuant to R.A. No. 7160 otherwise known as the Local Government Code of 1991 Particularly Section 444(b)(I) provides that the Chief Executive shall exercise general supervision and control over all programs, projects, services, and activities of the local government.

As part of Budget Preparation Activities, the Deliberation of Annual Executive Budget 2024 is imperative. This will help in maximizing the City's resources to bring the best economic, social and health services to the Fernandinos thru projects, programs and activities corresponding to their needs.
