#### Background:

Seminar on Sexual Orientation, Gender Identity, Gender Expression or SOGIE Empowerment.

The New Gender Code of CSFP, under Article 1 Section 5.26 states the definition of gender sensitivity as the ability to recognized gender issues and to recognized women's different perceptions and interest arising from their different social position and gender roles. In addition, under Article II Section 6.1.5 letter A defines the R.A 11313 the crimes of gender- based streets and public spaces sexual harassment are committed through any unwanted and uninvited sexual actions or remarks against any persons regardless of the motive in committing such actions or remarks.

In addition, this is where SOGIE seminar becomes useful as a first step to understanding particularly to LGBTQ and personal identity. In detail, Sexual Orientation refers to what type of gender one prefers sexually, Gender Identity is how one identifies oneself in gender, and Gender Expression is how people express themselves as what to wear or how one makes up. As such, each person's journey of self-awareness and expression is unique and individualized according to their culture, environment, and lived experiences.

#### Objective/s

• To adapt that there is an understanding at an international level that the issue in gender inequality should come from the equality of all people, the respect for human rights. SOGIE can bridge the current gap.
