

## TERMS OF REFERENCE

### Supply and Delivery of Wreath with Stand to be used in the Commemorations of National and Local Heroes in the City of San Fernando, Pampanga for 2<sup>nd</sup> Semester of 2023 subject to Ordering Agreement

#### I. BACKGROUND

A national hero of the Philippines is a Filipino who has been recognized as a hero for his or her role in the history of the country. It is often held on the birthday of a national hero or heroine, or the anniversary of their great deeds that made them heroes.

This year the City Government's celebration on the commemoration of local heroes & heroine will still be through wreath laying ceremony provided there will still be social distancing during the ceremony and following the standard protocols.

#### II. BUDGETARY REQUIREMENT

Supply and Delivery of Wreath with Stand to be used in the Commemorations of National and Local Heroes in the City of San Fernando, Pampanga for 2<sup>nd</sup> Semester of 2023 subject to Ordering Agreement, is included in the PPMP with **Ref. No. 2023 – 1363**, which is in the amount of SEVENTY-TWO THOUSAND PESOS (P 72,000.00).

#### III. OBJECTIVES

- To inculcate the sense of patriotism in all students and schools both public and private in the city
- To impart to the students the organization of a cultural activity in relation to our local heroes.
- To give importance to the heroism of our national/local heroes and heroine
- To inculcate and develop a sense of pride and place and heritage to the students in particular

#### IV. TERMS AND CONDITIONS

During the procurement process and delivery/ implementation of the contract, the end- user and the supplier/ contractor shall:

b. Procurement Process

1. For the End- user, ensure the completion of the documents in order to proceed with the procurement process.
2. For the supplier/ provider, ensure the completeness of the documents being required by the Bids and Awards Committee (BAC) for the procurement process on- time based on the procurement schedule including this TOR duly signed by the end- user and confirmed by the supplier/ provider.
3. If the procurement process reaches the ensuing year, observe that the allowed delivery is only up to what is stipulated in the contract.
4. For the End- user, present clearly this TOR during the Pre- Bid Conference for the information of the prospective bidder/s (for Competitive/ Public Bidding), and present by the Buyer with the assistance of the End- user (for Alternative Methods of Procurement).
5. Ensure that there are readily- available supplies upon submission of Request for Quotation (RFQ)/ Bid since delivery is anticipated upon issuance of PO/ Contract.
6. Comply with the provisions of the Procurement Law regardless of the mode of procurement, whether Competitive/ Public Bidding or the use of Alternative Methods of Procurement.

c. Delivery/ Implementation period

1. Strictly observe the "No Purchase Order (PO)/ Contracts, No Delivery" Policy and comply with the delivery period.
2. The Delivery Period shall follow the scheduled dates above.
3. During the delivery, strictly follow the provisions enumerated in the Terms and Condition of the PO/ Contract including the Delivery Schedule, Penalty, among others.
4. In case there is a change in the Delivery Schedule and specifications, the End- user through the Procurement Officer shall coordinate with the CGSO- Procurement Management Division (PMD) for the latter to advise the supplier/ contractor regarding the concern.
5. Coordination with the supplier/contractor shall be the function of the CGSO- PMD as its mandate.
6. For onsite delivery, ensure the coordination with the Inspector from the CGSO- Property and Supply Management Division (PSMD) for the inspection of the delivery in terms of quantity and quality of wreaths with stand and to immediately notify the supplier/ contractor in case of any concerns before the acceptance.

d. Inspection and Acceptance

The End-user shall accept the delivery with the (1) delivery receipts, and submit immediately to the Inspector of CGSO-PSMD together with the attendance sheet/s as part of the utilization where the quantity of the delivery is the same as the number of attendees and photo documentation of the delivery.

Such documents will be used in notifying the concerned offices on the delivery such as the City Accountant's Office (CAccO) and Commission on Audit (COA) to include the same in the Payables.

**V. DELIVERABLES BY THE SUPPLIER/ CONTRACTOR AND THE CITY GOVERNMENT**

The deliverables of the supplier/ contractor shall be as follows:

- a. Deliver the correct quantity of the wreaths with stand to the specified location, be it a monument or heritage site, on time.
- b. Strictly follow the specifications and timely provision of requirements based on the delivery schedule.
- c. Assign a representative who will coordinate and comply with all the documentary requirements of the project.


The deliverables of the City Government shall be as follows:

- a. To order/request the quantity of wreaths with stand to be delivered at the specific location;
- b. Provide payment upon the completion of the service and appropriate billing documents.
- c. End- user shall monitor the delivery of requirements.
- d. The Procurement Officer shall assist in the monitoring, delivery and on- time payment of the supplier.
- e. Provide necessary and readily- available documents such as during the conduct of post- audit.
- f. Evaluate the performance of the supplier/ contractor and in case there is a violation to the Contract/ Agreement, prepare a Verified Report.
