Invitation to Bid for the Supply and Delivery of Janitorial Supplies for 2nd Semester of 2018 to be used by the City Economic Enterprise Division, City Administrator's Office, CGSO-Utility, Maintenance and Services Division, CHO-Birthing Station & City Mayor's Office, City of San Fernando, Pampanga subject to Ordering Agreement

The City Government of San Fernando, Pampanga, through the **General Fund 2018** intends to apply the sum of **TWO MILLION THREE HUNDRED SEVENTY NINE THOUSAND TWO HUNDRED SEVEN PESOS & NINETY ONE CENTAVOS ONLY (P2,379,207.91)** being the Approved Budget for the Contract (ABC) to payments under the contract for **J3-18-1766** consisting of **Five (5) lots**, to wit:

- (a) Lot 1 – City Economic Enterprise Division, with an ABC of P15,326.86
- (b) Lot 2 – City Administrator's Office, with an ABC of P95,647.90
- (c) Lot 3 – CGSO-Utility, Maintenance and Services Division, with an ABC of P1,784,526.90
- (d) Lot 4 – City Health Office-Birthing Station, with an ABC of P120,986.55
- (e) Lot 5 – City Mayor's Office, with an ABC of P362,719.70

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

The City Government of San Fernando, Pampanga Bids and Awards Committee now invites bids for **Supply and Delivery of Janitorial Supplies for 2nd Semester of 2018 to be used by the City Economic Enterprise Division, City Administrator's Office, CGSO-Utility, Maintenance and Services Division, CHO-Birthing Station & City Mayor's Office, City of San Fernando, Pampanga subject to Ordering Agreement**. Delivery of the Goods is required **6 months**. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Interested bidders may obtain further information from the City Government of San Fernando, Pampanga and inspect the Bidding Documents at the address given below during 8:00 a.m. to 5:00 p.m.

A complete set of Bidding Documents may be acquired by interested Bidders on **JULY 31, 2018 (TUESDAY) until 1:00 p.m. of AUGUST 21, 2018 (TUESDAY)** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the following amounts:

- (a) Lot 1: **FIVE HUNDRED PESOS ONLY (P500.00);**
- (b) Lot 2: **FIVE HUNDRED PESOS ONLY (P500.00);**
- (c) Lot 3: **FIVE THOUSAND PESOS ONLY (P5,000.00);**
- (d) Lot 4: **FIVE HUNDRED PESOS ONLY (P500.00); and**
- (e) Lot 5: **FIVE HUNDRED PESOS ONLY (P500.00).**

The City Government of San Fernando, Pampanga will hold a Pre-Bid Conference on **AUGUST 07, 2018 (TUESDAY) 3:00 p.m. at CGSO Building, New Public Market, Del Pilar, City of San Fernando, Pampanga**, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before **1:00 p.m. of AUGUST 21, 2018 (TUESDAY) at CGSO Building, New Public Market, Del Pilar, City of San Fernando, Pampanga**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in Instruction to Bidders (ITB) Clause 18.

Bid opening shall be on **AUGUST 21, 2018 (TUESDAY) 1:30 p.m. at CGSO Building, New Public Market, Del Pilar, City of San Fernando, Pampanga**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The City Government of San Fernando reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
