**Invitation to Bid for the Supply and Delivery of Drugs and Medicines for 2nd Semester of 2018 to be used for the different programs of the City Health Office in the City of San Fernando, Pampanga subject to Ordering Agreement**

The City Government of San Fernando, Pampanga, through the **General Fund 2018** intends to apply the sum of **TWO MILLION NINE HUNDRED NINETY NINE THOUSAND SIX HUNDRED TWENTY FIVE PESOS & SIXTY CENTAVOS ONLY (P2,999,625.60)** being the Approved Budget for the Contract (ABC) to payments under the contract for **D2-18-1928** consisting of **Seven (7) lots**, to wit:

- Lot 1 – TB in Child Program, with an ABC of P209,000.00
- Lot 2 – Social Hygiene Clinic, with an ABC of P89,978.70
- Lot 3 – CVD Program, with an ABC of P629,965.00
- Lot 4 – CARI Program, with an ABC of P399,992.32
- Lot 5 – Maternal and Child Healthcare Program, with an ABC of P299,718.00
- Lot 6 – General Medical Services Program, with an ABC of P1,340,981.58
- Lot 7 – CDD Program, with an ABC of P29,990.00

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

The City Government of San Fernando, Pampanga Bids and Awards Committee now invites bids for **Supply and Delivery of Drugs and Medicines for 2nd Semester of 2018 to be used for the different programs of the City Health Office in the City of San Fernando, Pampanga subject to Ordering Agreement**. Delivery of the Goods is required **6 months**. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Interested bidders may obtain further information from the City Government of San Fernando, Pampanga and inspect the Bidding Documents at the address given below during 8:00 a.m. to 5:00 p.m.

Bid opening shall be on **SEPTEMBER 18, 2018 (TUESDAY) 1:30 p.m. at CGSO Building, New Public Market, Del Pilar, City of San Fernando, Pampanga**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The City Government of San Fernando reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
