The City Government of San Fernando, Pampanga, through the **General Fund 2018** intends to apply the sum of **NINE MILLION EIGHT HUNDRED THIRTY THREE THOUSAND ONE HUNDRED PESOS ONLY (P9,833,100.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **E3-18-2146** consisting of **Fifteen (15) lots**, to wit:

Delivery of the Goods is required **30 days**. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bid opening shall be on **SEPTEMBER 25, 2018 (TUESDAY) 1:30 p.m. at CGSO Building, New Public Market, Del Pilar, City of San Fernando, Pampanga**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The City Government of San Fernando reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
