Invitation to Bid for the Supply and Delivery of Drugs and Medicines for 1st Semester of 2019 to be used for the different programs of the City Health Office in the City of San Fernando, Pampanga subject to Ordering Agreement

The City Government of San Fernando, Pampanga, through the **General Fund 2019** intends to apply the sum of **THREE MILLION FOUR HUNDRED NINETY NINE THOUSAND NINE HUNDRED SEVENTY ONE PESOS & THIRTY THREE CENTAVOS ONLY (P3,499,971.33)** being the Approved Budget for the Contract (ABC) to payments under the contract for **D2-19-0683** consisting of **Six (6) lots**, to wit:

- Lot 1 – CVD Program, with an ABC of P1,150,706.00
- Lot 2 – CARI Program, with an ABC of P133,092.00
- Lot 3 – CDD Program, with an ABC of P45,041.35
- Lot 4 – General Medical Services Program, with an ABC of P1,727,831.98
- Lot 5 – Maternal and Child Healthcare Program, with an ABC of P234,300.00
- Lot 6 – TB in Child Program, with an ABC of P209,000.00

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

The City Government of San Fernando, Pampanga Bids and Awards Committee now invites bids for **Supply and Delivery of Drugs and Medicines for 1st Semester of 2019 to be used for the different programs of the City Health Office in the City of San Fernando, Pampanga subject to Ordering Agreement**. Delivery of the Goods is required within ten (10) days upon receipt of Notice to Proceed (NTP). Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Interested bidders may obtain further information from the City Government of San Fernando, Pampanga and inspect the Bidding Documents at the address given below during 8:00 a.m. to 5:00 p.m.

All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in Instruction to Bidders (ITB) Clause 18.

Bid opening shall be on **APRIL 11, 2019 (THURSDAY) 1:30 p.m. at CGSO Building, New Public Market, Del Pilar, City of San Fernando, Pampanga**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The City Government of San Fernando reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
