**Invitation to Bid for the Contract of Service for Disposal of Residual Waste to Sanitary Landfill of the City Government of San Fernando, Pampanga.**

The City Government of San Fernando, Pampanga, through the **General Fund 2019** intends to apply the sum of **FIVE MILLION EIGHT HUNDRED SIXTY FOUR THOUSAND SIX HUNDRED SEVENTY PESOS ONLY (P5,864,670.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **S5-19-2705**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The City Government of San Fernando, Pampanga now invites bids for the **Contract of Service for Disposal of Residual Waste to Sanitary Landfill of the City Government of San Fernando, Pampanga**. Delivery of the Goods is required within **Thirty (30) days** upon receipt of Notice to Proceed (NTP). Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Interested bidders may obtain further information from the City Government of San Fernando, Pampanga and inspect the Bidding Documents at the address given below during 8:00 a.m. to 5:00 p.m.

A complete set of Bidding Documents may be acquired by interested Bidders on **NOVEMBER 14, 2019 (THURSDAY) until 1:00 p.m. of DECEMBER 03, 2019 (TUESDAY)** from the address below and upon payment of the applicable fee for the Bidding Documents in the amount of **TEN THOUSAND PESOS ONLY (P10,000.00)**.

The City Government of San Fernando, Pampanga will hold a Pre-Bid Conference on **NOVEMBER 21, 2019 (THURSDAY) 3:00 p.m.** at **CGSO Building, New Public Market, Del Pilar, City of San Fernando, Pampanga**, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before **1:00 p.m. of DECEMBER 03, 2019 (TUESDAY) at CGSO Building, New Public Market, Del Pilar, City of San Fernando, Pampanga**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in Instruction to Bidders (ITB) Clause 18.

Bid opening shall be on **DECEMBER 03, 2019 (TUESDAY) 1:30 p.m. at CGSO Building, New Public Market, Del Pilar, City of San Fernando, Pampanga**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The City Government of San Fernando reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.

### **TERMS OF REFERENCE**

#### **I. RATIONALE**

The City Government of San Fernando, Pampanga through the City Environment and Natural Resources Office is doing its best in restoring, protecting and preserving our environment. One of the programs of the City Government is the strict implementation of the RA 9003 or the Ecological Solid Waste Management Act of 2000. The city continuously generates residual solid waste and is looking for a sanitary landfill facility as final disposal for such residual solid waste.

#### **II. OBJECTIVES**

- a) Compliance to RA 9003
- b) To clear accumulated residual waste at the City Transfer Station

#### **III. SCOPE AND COVERAGE OF SERVICES**


Work to be done:

- a) The service provider shall manage and operate a Sanitary Landfill in accordance with RA 9003
- b) The service provider shall guarantee and undertake the transport and dispose collected residual waste in accordance with RA 9003
- c) The basis of tipping fee shall be in cubic meter
