Invitation to Bid for the Supply and Delivery of Common Used Office Supplies for 1st Semester of 2021 to be used at CGSO-RAMD, CHO-CNC, OCBO, CMO-City of San Fernando-Police Station, CMO, CMO-BJMP, CACCO and CDRRMD in the City of San Fernando, Pampanga subject to Ordering Agreement

1. The City Government of San Fernando, Pampanga, through the **General Fund 2021** intends to apply the sum of **FOUR MILLION THIRTY FOUR THOUSAND FOUR HUNDRED ELEVEN PESOS AND 59/100 ONLY (P4,034,411.59)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Supply and Delivery of Common Used Office Supplies for 1st Semester of 2021 to be used at CGSO-RAMD, CHO-CNC, OCBO, CMO-City of San Fernando-Police Station, CMO, CMO-BJMP, CACCO and CDRRMD in the City of San Fernando, Pampanga subject to Ordering Agreement / O4-21-0559** consisting of **Eight (8) lots**, to wit:

LOT 1 – CGSO – Records and Archives Management Division with an ABC of P70,285.75
LOT 2 – CHO – City Nutrition Committee with an ABC of P215,780.00
LOT 3 – Office of the City Building Official with an ABC of P790,854.21
LOT 4 – City of San Fernando – Police Station with an ABC of P95,313.48
LOT 5 – City Mayor’s Office with an ABC of P1,971,061.53
LOT 6 – CMO – Bureau of Jail Management and Penology with an ABC of 97,371.30
LOT 7 – City Accounting Office with an ABC of 674,474.32
LOT 8 – City Disaster Risk Reduction and Management Division with an ABC of 119,271.00

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The City Government of San Fernando, Pampanga now invites bids for the above Procurement Project. Delivery of the Goods is required within **Thirty (30) days** upon receipt of Notice to Proceed (NTP). Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from City Government of San Fernando, Pampanga and inspect the Bidding Documents at the address given below during 8:00 a.m. to 5:00 p.m.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **APRIL 26, 2021 (MONDAY) until 1:00 p.m. of MAY 18, 2021 (TUESDAY)** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the following amounts:

LOT 1 : FIVE HUNDRED PESOS ONLY (P500.00);
LOT 2 : FIVE HUNDRED PESOS ONLY (P500.00);
LOT 3 : ONE THOUSAND PESOS ONLY (P1,000.00);
LOT 4 : FIVE HUNDRED PESOS ONLY (P500.00);
LOT 5 : FIVE THOUSAND PESOS ONLY (P5,000.00);
LOT 6 : FIVE HUNDRED PESOS ONLY (P500.00);
LOT 7 : ONE THOUSAND PESOS ONLY (P1,000.00);
LOT 8 : FIVE HUNDRED PESOS ONLY (P500.00)

The Procuring Entity shall allow the bidder to present its proof of payment for the fees that will be presented in person.

6. The City Government of San Fernando, Pampanga will hold a Pre-Bid Conference for this project on **MAY 04, 2021 (TUESDAY) 3:00 p.m.** at **CGSO Building, New Public Market, Del Pilar, City of San Fernando, Pampanga**, and shall be open to prospective bidders via videoconference.
7. Bids must be duly received by the BAC Secretariat through manual submission on or before **1:00 p.m. of MAY 18, 2021 (TUESDAY) at CGSO Building, New Public Market, Del Pilar, City of San Fernando, Pampanga**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. Bid opening shall be on **MAY 18, 2021 (TUESDAY) 2:00 p.m. at CGSO Building, New Public Market, Del Pilar, City of San Fernando, Pampanga**. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity via videoconference.

10. The City Government of San Fernando, Pampanga reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
