**REQUEST FOR EXPRESSION OF INTEREST**

**Contract of Three (3) Year Consultancy Services on Data Privacy Management in the City of San Fernando, Pampanga**

1. The City Government of San Fernando, Pampanga, through the **General Fund 2021** intends to apply the sum of **TWO MILLION FIVE HUNDRED THOUSAND PESOS ONLY (P2,500,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Contract of Three (3) Year Consultancy Services on Data Privacy Management in the City of San Fernando, Pampanga**. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
2. The City Government of San Fernando, Pampanga now calls for the submission of eligibility documents for **Contract of Three (3) Year Consultancy Services on Data Privacy Management in the City of San Fernando, Pampanga**. Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before **12 nn of JUNE 09, 2021 (WEDNESDAY) at CGSO Building, New Public Market, Del Pilar, City of San Fernando, Pampanga**. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.
3. Interested bidders may obtain further information from City Government of San Fernando, Pampanga and inspect the Bidding Documents at the address given below during **8:00 a.m. to 5:00 p.m.**
4. A complete set of Bidding Documents may be acquired by the shortlisted Bidder on **JUNE 11, 2021 (FRIDAY) until 1:00 p.m. of JUNE 29, 2021 (TUESDAY) at CGSO Building, New Public Market, Del Pilar, City of San Fernando, Pampanga** and upon payment of a non-refundable fee for the bidding documents in the amount **FIVE THOUSAND PESOS ONLY (P5,000.00)**.
5. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). The criteria and rating system for short listing are:

<b>Evaluation Criteria</b>	<b>Weight</b>	<b>Minimum Required Score</b>
1. Applicable experience of the consultant and members;	<b>50%</b>	<b>45%</b>
2. Qualification of Personnel who may be assigned to the job vis-à-vis extent and complexity of the undertaking; and	<b>30%</b>	<b>25%</b>
3. Current workload relative to capacity	<b>20%</b>	<b>15%</b>
<b>Total</b>	<b>100%</b>	<b>85%</b>

6. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184.  
  
Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least **sixty percent (60%)** interest or outstanding capital stock belonging to citizens of the Philippines.
7. The Procuring Entity shall evaluate bids using the **Quality-Cost Based Evaluation (QCBE)**, procedure. The allocated weights for the **Technical Proposal is sixty percent (60%)** and for **Financial Proposal is forty percent (40%)**. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
8. The contract shall be completed within **three (3) years from July 2021 - December 2023**.
9. The City Government of San Fernando, Pampanga reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
