The City Government of San Fernando, Pampanga, through the Approved Budget 2014 intends to apply the sum of **FIVE HUNDRED EIGHTY EIGHT THOUSAND SEVEN HUNDRED TWENTY PESOS ONLY (P588,720.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **ES-G3-14-0749**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The City Government of San Fernando, Pampanga now invites bids for the **Supply and Delivery of New Uniforms and Traffic Paraphernalia for Traffic Enforcers of Traffic Management Division of the City of San Fernando, Pampanga**. Delivery of Goods is required to thirty (30) days upon receipt of the contract. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Interested bidders may obtain further information from the City Government of San Fernando, Pampanga and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m.

Bids must be delivered to the address below on or before **10:00 a.m. of APRIL 10, 2014 (THURSDAY) at CGSO Building, New Public Market, Del Pilar, City of San Fernando, Pampanga**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in Instruction to Bidders (ITB) Clause 18.

Bid opening shall be on **APRIL 10, 2014 (THURSDAY) 10:30 a.m. at CGSO Building, New Public Market, Del Pilar, City of San Fernando, Pampanga** will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
