

EXECUTIVE ORDER NO. CMO 2013 – 024

AN ORDER CREATING THE CITY OF SAN FERNANDO, PAMPANGA’S EXECUTIVE COMMITTEE ON LOCAL HISTORY WRITING

WHEREAS, the City of San Fernando, Pampanga recognizes its rich tradition in history and culture and commits itself to the preservation of these;

WHEREAS, the City Government of San Fernando, Pampanga deems it appropriate to organize the membership of the council to produce a working paper on the history of the City and its 35 barangays;

WHEREAS, the City Government of San Fernando, Pampanga espouses good governance by working in partnership with the private sector to ensure the success of its programs;

WHEREAS, in the desire and strong commitment of the Local Government Unit of San Fernando, Pampanga to further enhance and promote its local culture and tourism industry, the City is requiring the services of a professional historian and educator who can act as Cultural and Tourism Consultant;

NOW, THEREFORE, by the powers vested in me by law, I, Edwin D. Santiago, City Mayor of San Fernando, Pampanga, do hereby order the organization of the CSFP Executive Committee on Local History Writing and appoint its members as follows:

Section 2. DUTIES AND FUNCTIONS: The functions of the Committee on Local History Writing are as follows:

1. Prepare an annual plan on the local history writing program;
2. Coordinate with local and national cultural agencies and organizations;
3. Encourage the researching, writing and publishing of the City of San Fernando's local history;
4. Involve locals directly in the writing of the history;
5. Produce a well-researched and well-written coffee table or history book of the City.

Section 3. SECRETARIAT: The City Tourism and Investment Promotion Office shall serve as the Secretariat of the Council.

Section 4. EFFECTIVITY: This Executive Order shall take effect immediately.
