TERMS OF REFERENCE

SUPPLY AND DELIVERY OF TEACHER'S TABLES AND CHAIRS TO BE USED AT THE CITY COLLEGE OF SAN FERNANDO PAMPANGA

I.BACKGROUND

The City College of San Fernando Pampanga has been operating and rendering quality education to its community for fourteen years. From its education services, several areas of improvement are to be considered to attain the learning success of the ASLAG students. An essential predictor that influences the academic achievement of the students is their learning surroundings, and one aspect is the physical environment which includes the school's physical plant, facilities and equipment, and other needed resources and supplies that help students and teachers in the improvement of teaching and learning process which paves the way to a better learning outcome.

As CCSFP continuously grows in terms of its population, due to the new programs offered, both human and physical resources are needed to meet the needs of the increasing demands of the school community members. In this light, the College President and City Government of San Fernando have decided to plan and have taken into action the construction of a new campus located at Del Rosario San Fernando Pampanga for CCSFP which aims to cater the more than one thousand and three hundred students and the additional freshmen who will be enrolling for the new programs offering.

The CCSFP College President has created a Committee on Transfer on New Campus (CTNC) to ensure that the Del Rosario Campus is ready for occupancy by August 2023. Specifically, in the preparation of documents for goods and services to be procured, coordinate with various offices regarding requests for specific design requirements and undertake relevant activities which will contribute to the smooth and timely transfer as targeted.

In our search to continue and sustain the provision of quality education for the new campus, the CTNC has proposed a project entitled "New Campus! New Great Environment! in order to equate the imbalances between its operation and resources.

II.BUDGETARY REQUIREMENT

The budgetary requirement for the Supply and Delivery of Teacher's Tables and Chairs to be used at the City College of San Fernando Pampanga is included in the **PPMP with Ref. No. 2023-2873** and already included in the Annual Procurement Plan (APP) of the City Government, which is in the amount of **ONE HUNDRED EIGHTY SEVEN THOUSAND PESOS (PHP 187,000.00).**

III.OBJECTIVES

The objectives of the Supply and Delivery of Teacher's Tables and Chairs to be used at the City College of San Fernando Pampanga as follows:

1. To effectively facilitate the teaching – learning process.
2. To contribute a more productive and better learning environment.

IV.TERMS AND CONDITIONS

During the procurement process and delivery/ implementation of the contract, the end- user and the supplier/ contractor shall:

- a. Specifications/ Schedule of Requirements

b. Procurement Process

1. For the End- user, ensure the completion of the documents in order to proceed with the procurement process.
2. For the supplier/ provider, ensure the completeness of the documents being required by the Bids and Awards Committee (BAC) for the procurement process on- time based on the procurement schedule including this TOR duly signed by the end- user and conformed by the supplier/ contractor.
3. If the procurement process reaches the ensuing year, observe that the allowed transaction is only up to what is stipulated in the contract.
4. For the End- user, present clearly this TOR during the Pre- Bid Conference for the information of the prospective bidder/s (for Competitive/ Public Bidding), and present by the Buyer with the assistance of the End- user (for Alternative Methods of Procurement).
5. Ensure to supply the requirements upon issuance of DOC.
6. Comply with the provisions of the Procurement Law regardless of the mode of procurement, whether Competitive/ Public Bidding or the use of Alternative Methods of Procurement.

c. Delivery/ Implementation period

1. Strictly observe the "No Purchase Order (PO)/ Delivery Order Contract (DOC), No Delivery" Policy and comply with the delivery period.
2. The Delivery Period shall be from July to September 2023, and the contract shall end by the end of December 2023. By the end of the contract, the end- user can no longer prepare Order List and no DOC will be issued for the purpose.
3. During the delivery, strictly follow the provisions enumerated in the Terms and Condition of the PO/ Contract including the Delivery Schedule, Penalty, among others.
4. In case there is a change in the Delivery Schedule and specifications, the End- user through the Procurement Officer shall coordinate with the CGSO- Procurement Management Division (PMD) for the latter to advise the supplier/ contractor regarding the concern.
5. Coordination with the supplier/ contractor shall be the function of the CGSO- PMD as its mandate.

d. Inspection and Acceptance

1. The CGSO- PSMD shall inspect and accept the delivery.
2. The supplier/contractor shall present the PO and issue Sales Invoice.
3. The CGSO- PSMD shall prepare the corresponding Inspection and Acceptance Report/s.

Such documents will be used in notifying the concerned offices on the delivery such as the City Accountant's Office (CAccO) and Commission on Audit (COA) to include the same in the Payables.

V. DELIVERABLES BY THE SUPPLIER/ CONTRACTOR AND THE CITY GOVERNMENT

The deliverables of the supplier/ contractor shall be as follows:

- a. Provide the quantity of the teacher's tables and chairs with the stated specifications being required by the project/ program; and
- b. Strictly follow the specifications and timely provision of requirements based on the delivery schedule.

The deliverables of the City Government shall be as follows:

- a. On- time payment of the supplier/ contractor i.e., 15 days after the delivery.
- b. End- user shall monitor the delivery.
- c. The Procurement Officer shall assist in the monitoring and on- time payment of the supplier/ contractor.
- d. Provide necessary and readily- available documents such as during the conduct of post-audit.
- e. Evaluate the performance of the supplier/ contractor and in case there is a violation to the Contract/ Agreement, prepare a Verified Report.


