### **Background:**

Section 16 of the Local Government Code or RA 7160 mandates all local government units to ensure and maintain peace and order within their respective areas of jurisdiction. Section 116 of the said law also states that a Peace and Order Council (POC) shall be established in every province, city, and municipality.

Under Section 3 (a) of DILG-MC No. 2015-130 dated November 3, 2015 provides that the Barangay Peace and Order Council shall prepare a three-year Barangay Peace and Order and Public Safety (BPOPS) Plan.

Under Section 4 (iii) of Dangerous Drugs Board (DDB) Regulation No. 4 dated 19 September 2016 provides that all city and municipal mayors are enjoined to ensure that every barangay in their respective jurisdiction shall formulate the Barangay Peace and Order and Public Safety (BPOPS) Plan and Barangay Anti-Illegal Drug Abuse Council (BADAC) Plan of Action as its component.

Under DILG Memorandum Circular No. 2017-142 dated October 23, 2017, the guidelines for the formulation of a Simplified Barangay Peace and Order and Public Safety (BPOPS) Plan highlighting on Section 4 (1) that the BPOC and BADAC, preferably, with the presence and participation of the other members of the sangguniang barangay, barangay secretary and barangay treasurer.

Currently, all thirty-five (35) barangays has an outdated BPOPS Plan for 2023-2025 coverage period.

### **Objective/s**

The workshop aims to:

- Increase knowledge and understanding on the barangay peace and order and public safety;
- Identify the barangays' strengths, weaknesses, opportunities and threats relative to the current state of the barangay peace and order and public safety as an organization;

### **Budgetary Requirements:**

- e. Evaluate the performance of the supplier/ contractor and in case there is a violation to the Contract/ Agreement, prepare a Verified Report.


