TERMS OF REFERENCE

SUPPLY, DELIVERY AND INSTALLATION OF PLAGIARISM CHECKER TO BE USED AT THE CITY COLLEGE OF SAN FERNANDO PAMPANGA

I.BACKGROUND

Research is one of the trifocal functions of a higher educational institution (HEI), instruction and extension being the other two. All HEI personnel and students are therefore expected to conduct research. It is the role of the HEI to ascertain the technical soundness and integrity of all submitted studies. A software which can perform these functions will contribute to the efficiency in the evaluation process of submitted papers.

Such software is likewise very useful in ensuring the quality of written documents (e.g., position papers, agreements, letters, etc.) of diverse and flexible teaching and learning modalities

II.BUDGETARY REQUIREMENT

The budgetary requirement for the Supply, Delivery and Installation of Plagiarism Checker to be used at the City College of San Fernando, Pampanga in the City of San Fernando, Pampanga is included in the PPMP with Ref. No. 2023-2153 and already included in the Annual Procurement Plan (APP) of the City Government, which is in the amount of **ONE HUNDRED SIXTY THOUSAND PESOS (PHP 160,000.00).**

III.OBJECTIVES

The objectives of the Supply, Delivery and Installation of Plagiarism Checker to be used at the City College of San Fernando, Pampanga are as follows:

- To help faculty members and lessen their time in checking the authenticity of student's work.
- 2. To facilitate the evaluation process of submitted research papers in terms of technical soundness and integrity.
- 3. To further enhance the standard of written documents being done in the institution.

IV.TERMS AND CONDITIONS

During the procurement process and delivery/ implementation of the contract, the end- user and the supplier/ contractor shall:

b. Procurement Process

 For the End- user, ensure the completion of the documents in order to proceed with the procurement process.

For the supplier/ provider, ensure the completeness of the documents being required by
the Bids and Awards Committee (BAC) for the procurement process on- time based on
the procurement schedule including this TOR duly signed by the end- user and
conformed by the supplier/ contractor.

3. If the procurement process reaches the ensuing year, observe that the allowed transaction

is only up to what is stipulated in the contract.

4. For the End- user, present clearly this TOR during the Pre- Bid Conference for the information of the prospective bidder/s (for Competitive/ Public Bidding), and present by the Buyer with the assistance of the End- user (for Alternative Methods of Procurement).

5. Ensure to supply the requirements upon issuance of DOC.

 Comply with the provisions of the Procurement Law regardless of the mode of procurement, whether Competitive/ Public Bidding or the use of Alternative Methods of Procurement.

c. Delivery/ Implementation period

 Strictly observe the "No Purchase Order (PO)/ Delivery Order Contract (DOC), No Delivery" Policy and comply with the delivery period.

2. The Delivery Period shall be from September - November 2023.

- 3. During the delivery, strictly follow the provisions enumerated in the Terms and Condition of the PO/ Contract including the Delivery Schedule, Penalty, among others.
- 4. In case there is a change in the Delivery Schedule and specifications, the End-user through the Procurement Officer shall coordinate with the CGSO- Procurement Management Division (PMD) for the latter to advise the supplier/contractor regarding the concern.
- Coordination with the supplier/ contractor shall be the function of the CGSO- PMD as its mandate.

d. Inspection and Acceptance

1. The CGSO- PSMD shall inspect and accept the delivery.

2. The supplier/contractor shall present the PO and issue Sales Invoice.

3. The CGSO- PSMD shall prepare the corresponding Inspection and Acceptance Report/s.

Such documents will be used in notifying the concerned offices on the delivery such as the City Accountant's Office (CAccO) and Commission on Audit (COA) to include the same in the Payables.

V.DELIVERABLES BY THE SUPPLIER/ CONTRACTOR AND THE CITY GOVERNMENT

The deliverables of the supplier/contractor shall be as follows:

a. Provide the quantity of the plagiarism checker with the stated specifications being required by the project/ program; and

b. Strictly follow the specifications and timely provision of requirements based on the delivery schedule.

The deliverables of the City Government shall be as follows:

- a. On-time payment of the supplier/contractor i.e., 15 days after the delivery.
- b. End- user shall monitor the delivery.
- c. The Procurement Officer shall assist in the monitoring and on- time payment of the supplier/ contractor.
- d. Provide necessary and readily- available documents such as during the conduct of post-
- Evaluate the performance of the supplier/ contractor and in case there is a violation to the Contract/ Agreement, prepare a Verified Report.
