## <u>Invitation to Bid for the Supply and Delivery of Office Supplies to be used at the various Birthing Stations of</u> the City Health Office for 2023 in the City of San Fernando, Pampanga

- 1. The City Government of San Fernando, Pampanga, through the **General Fund 2023** intends to apply the sum of **ONE HUNDRED SEVENTY-SIX THOUSAND SIXTY-SEVEN PESOS AND 83/100 ONLY (P176,067.83)** being the ABC to payments under the contract for **Supply and Delivery of Office Supplies to be used at the various Birthing Stations of the City Health Office for 2023 in the City of San Fernando, Pampanga / 2023-10-02388**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The City Government of San Fernando, Pampanga now invites bids for the above Procurement Project. Delivery of the Goods is required within **Twenty (20) Days** upon receipt of Notice to Proceed (NTP). Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from City Government of San Fernando, Pampanga and inspect the Bidding Documents at the address given below during 8:00 a.m. to 5:00 p.m.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on OCTOBER 23, 2023 (MONDAY) until 1:00 p.m. of NOVEMBER 17, 2023 (FRIDAY) at CGSO Building, New Public Market, Del Pilar, City of San Fernando, Pampanga and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of FIVE HUNDRED PESOS ONLY (P500.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees that will be presented in person.
- 6. The City Government of San Fernando, Pampanga will hold a Pre-Bid Conference on NOVEMBER 03, 2023 (FRIDAY) 2:30 p.m. at Levi Panlilio, Conference Room, City Hall, Sto. Rosario, City of San Fernando, Pampanga, and shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission on or before 1:00 pm of NOVEMBER 17, 2023 (FRIDAY) at Levi Panlilio, Conference Room, City Hall, Sto. Rosario, City of San Fernando, Pampanga. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on NOVEMBER 17, 2023 (FRIDAY) 2:00 p.m. at Levi Panlilio, Conference Room, City Hall, Sto. Rosario, City of San Fernando, Pampanga. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The City Government of San Fernando, Pampanga reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
