Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from City Government of San Fernando, Pampanga and inspect the Bidding Documents at the address given below during 8:00 a.m. to 5:00 p.m.
- 5. The Procuring Entity shall allow the bidder to present its proof of payment for the fees that will be presented in person.
- 6. The City Government of San Fernando, Pampanga will hold a Pre-Bid Conference on NOVEMBER 03, 2023 (FRIDAY) 2:30 p.m. at Levi Panlilio, Conference Room, City Hall, Sto. Rosario, City of San Fernando, Pampanga, and shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission on or before 1:00 pm of NOVEMBER 17, 2023 (FRIDAY) at Levi Panlilio, Conference Room, City Hall, Sto. Rosario, City of San Fernando, Pampanga. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause
- 9. Bid opening shall be on NOVEMBER 17, 2023 (FRIDAY) 2:00 p.m. at Levi Panlilio, Conference Room, City Hall, Sto. Rosario, City of San Fernando, Pampanga. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The City Government of San Fernando, Pampanga reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
