TERMS OF REFERENCE

SUPPLY AND DELIVERY OF OFFICE FURNITURE TO BE USED FOR THE SPECIAL DRUG EDUCATION CENTER (SDEC) OPERATIONS AT CIVIC CENTER IN THE CITY OF SAN FERNANDO, PAMPANGA

I.BACKGROUND

The City of San Fernando is very optimistic in addressing the uprising problem in the community. Through the City Social Welfare and Development Office (CSWD) the continuous advocacy of the city will be carried out thru various services that will enable this young people to maximize their potentials and actualize their duties. This can be supported on the Community Drug Abuse Rehabilitation Program which was initiated by the city. Such program has provision to implement community-based intervention among substance users using the four (4) dimensions; Physical and medical Dimension, Psychosocial, Spiritual and Vocational and Educational Dimension. This is in response to the mandate of Dangerous Drugs Board Regulation No.4 Series of 2016. Whereas, in accordance to Article IV, Section 46 of Republic Act No. 9165 known as Comprehensive Dangerous Drugs Act of 2002 states the establishment of Special Drug Education Center (SDEC) where drug prevention programs and activities be conducted for Out of School, Youth and street children.

The SDEC is a community-based facility which serves as a venue in promoting preventive and developmental services for the out of school youth, street children and for outpatient youth reformist. This aims to enable them to cope with the challenges of adolescence particularly their vulnerability to drug and substance abuse. It imparts the value of community and imbibes leadership skills by teaching them to serve as positive role models in rejecting the lure of drugs and in leading healthy and productive lives.

II.BUDGETARY REQUIREMENT

b. Procurement Process

- For the supplier/ provider, ensure the completeness of the documents being required by the Bids and Awards Committee (BAC) for the procurement process on- time base on the procurement schedule including this TOR duly signed by the end- user and conformed by the supplier/ contractor.
- 3. If the procurement process reaches the ensuing year, observe that the allowed transaction is only up to what is stipulated in the contract.
- 4. For the End- user, present clearly this TOR during the Pre- Bid Conference for the information of the prospective bidder/s (for Competitive/ Public Bidding), and present by the Buyer with the assistance of the End- user (for Alternative Methods of Procurement).
- 5. Ensure to supply the requirements upon issuance of DOC.
- Comply with the provisions of the Procurement Law regardless of the mode of procurement, whether Competitive/ Public Bidding or the use of Alternative Methods of Procurement.
- c. Delivery/ Implementation period
 - 1. Strictly observe the "No Purchase Order (PO)/ Delivery Order Contract (DOC), No Delivery" Policy and comply with the delivery period.
 - The Delivery Period shall be from November 2023, and the contract shall end by the end of December 2023. By the end of the contract, the end- user can no longer prepare Order List and no DOC will be issued for the purpose.

 - 4. In case there is a change in the Delivery Schedule and specifications, the End- user through the Procurement Officer shall coordinate with the CGSO- Procurement Management Division (PMD) for the latter to advise the supplier/ contractor regarding the concern.
 - Coordination with the supplier/ contractor shall be the function of the CGSO- PMD as its mandate.
- d. Inspection and Acceptance
 - 1. The CGSO- PSMD shall inspect and accept the delivery.
 - 2. The supplier/contractor shall present the PO and issue Sales Invoice.
 - 3. The CGSO- PSMD shall prepare the corresponding Inspection and Acceptance Report/s.

Such documents will be used in notifying the concerned offices on the delivery such as the City Accountant's Office (CAccO) and Commission on Audit (COA) to include the same in the Payables.

V.DELIVERABLES BY THE SUPPLIER/ CONTRACTOR AND THE CITY GOVERNMENT

The deliverables of the supplier/ contractor shall be as follows:

- a. Provide the quantity of the Office Furniture being required by the project/ program; and
- b. Strictly follow the specifications and timely provision of requirements based on the delivery schedule.

The deliverables of the City Government shall be as follows:

- a. On- time payment of the supplier/ contractor i.e., 15 days after the delivery.
- b. End- user shall monitor the delivery.
- c. The Procurement Officer shall assist in the monitoring and on- time payment of the supplier/ contractor.
- Provide necessary and readily- available documents such as during the conduct of postaudit.
- e. Evaluate the performance of the supplier/ contractor and in case there is a violation to the Contract/ Agreement, prepare a Verified Report.
