TERMS OF REFERENCE

SUPPLY, DELIVERY AND INSTALLATION OF RECREATIONAL AND PARK FITNESS & EXERCISE OUTDOOR EQUIPMENT FOR THE IMPROVEMENT OF GIANT LANTERN AND TOURIST INFORMATION CENTER PARK IN THE CITY OF SAN FERNANDO, PAMPANGA IN 2023

I. BACKGROUND

In recognition of the need to create among the people a consciousness of the rich culture and tradition, the City of San Fernando aims to create a Christmas Capital Park where Fernandinos and other tourist feel the Christmas vibes for the entire year. Some local souvenir shops, pasalubong stalls were also displayed in the area.

It is on this note that the City Government of San Fernando ought to continue to promote the city by having a whole year Christmas themed park which will be open for Fernandinos and tourist.

II. BUDGETARY REQUIREMENT

The Budgetary Requirement to be used for the Supply, Delivery and Installation of Recreational and Park Fitness & Exercise Outdoor Equipment for the Improvement of Giant Lantern and Tourist Information Center Park in the City of San Fernando, Pampanga in 2023 is included in the PPMP with Ref No. 2023-3376 and already included in the Annual Procurement Plan (APP) of the City Government, which is in the amount of TWO HUNDRED FIFTY THOUSAND PESOS (P250,000.00).

III. OBJECTIVES

- To attract tourist and local Kapampangans to visit the Home of the Giant Lanterns and recognize the City of San Fernando as Christmas Capital of the Philippines.
- To have a display of our lanterns and other related Christmas activities or attraction the whole year around at Giant Lantern Tourist and Information Center.
- To provide activity area for Fernandino Families by making them more active and improving their overall health through the establishment of the Giant Lantern and Tourist Information Center Park.

IV. TERMS AND CONDITIONS

During the procurement process and delivery/ implementation of the contract, the end-user and the supplier/ contractor shall:

a. Specifications/ Schedule of Requirements

b. Procurement Process

1. For the End- user, ensure the completion of the documents in order to proceed with the procurement process.
2. For the supplier/ provider, ensure the completeness of the documents being required by the Bids and Awards Committee (BAC) for the procurement process on- time based on the procurement schedule including this TOR duly signed by the end- user and conformed by the supplier/ provider.
3. If the procurement process reaches the ensuing year, observe that the allowed delivery is only up to what is stipulated in the contract.
4. For the End- user, present clearly this TOR during the Pre- Bid Conference for the information of the prospective bidder/s (for Competitive/ Public Bidding), and present by the Buyer with the assistance of the End- user (for Alternative Methods of Procurement).
5. Ensure that there are readily- available supplies upon submission of Request for Quotation (RFQ)/ Bid since delivery is anticipated upon issuance of PO/ Contract.
6. Comply with the provisions of the Procurement Law regardless of the mode of procurement, whether Competitive/ Public Bidding or the use of Alternative Methods of Procurement.

c. Delivery/ Implementation period

1. Strictly observe the "No Purchase Order (PO)/ Contracts, No Delivery" Policy and comply with the delivery period.
2. The Delivery Period shall be on ~~November-~~ December 2023.
3. During the delivery, strictly follow the provisions enumerated in the Terms and Condition of the PO/ Contract including the Delivery Schedule, Penalty, among others.
4. In case there is a change in the Delivery Schedule and specifications, the End- user through the Procurement Officer shall coordinate with the CGSO- Procurement Management Division (PMD) for the latter to advise the supplier/ contractor regarding the concern.
5. Coordination with the supplier/ contractor shall be the function of the CGSO- PMD as its mandate.
6. For onsite delivery, ensure the coordination with the Inspector from the CGSO- Property and Supply Management Division (PSMD) for the inspection of the delivery in terms of quantity and quality of equipment and to immediately notify the supplier/ contractor in case of any concerns before the acceptance.

d. Inspection and Acceptance

The End- user shall accept the delivery with the (1) delivery receipts, and submit immediately to the Inspector or CGSO- PSMD.

Such documents will be used in notifying the concerned offices on the delivery such as the City Accountant's Office (CAccO) and Commission on Audit (COA) to include the same in the Payables.

V. DELIVERABLES BY THE SUPPLIER/ CONTRACTOR AND THE CITY GOVERNMENT

The deliverables of the supplier/ contractor shall be as follows:


- a. Provide the quantity and specifications of recreational and park fitness & exercise outdoor equipment being required by the project/ program; and
- b. Strictly follow the specifications and timely provision of requirements based on the delivery schedule.

- c. Assign a representative who will coordinate and comply with all the documentary requirements of the project.
- d. Installation of the equipments and provide maintenance and warranty of the equipments for one (1) year.

The deliverables of the City Government shall be as follows:

- a. To coordinate and process the requirement of the supplier/contractor;
- b. The Procurement Officer shall assist in the monitoring, delivery and on- time payment of the supplier.
- c. Provide necessary and readily- available documents such as during the conduct of post- audit.
- d. Evaluate the performance of the supplier/ contractor and in case there is a violation to the Contract/ Agreement, prepare a Verified Report.


