- Project Location: City Engineer's Office, City of San Fernando, Pampanga
- **Background:** Pursuant to Section 454 (a), Chapter 2 of Republic Act (RA) 7160 known as the Local Government Code of 1991, the City Engineer is one of the mandatory position and/or official that must be included in the City Government. The creation of the City Engineer's Office CEO and its functions was based on the mentioned Code.

As enumerated in Article 7 Section 477 of the same, the functions of the CEO shall be focused on (1) initiating, reviewing and recommending policies, programs, plans and procedures in infrastructure development and public works, (2) administering, coordinating, supervision, control of construction, maintenance, improvement and repair of roads, bridges and other engineering and public works projects, (3) provision of Engineering Services to the City, among others.

Republic Act 11058 titled " An Act strengthening the compliance with occupational safety and health standards and providing penalties for violating thereof" provides that the State shall protect every worker against injury, sickness or death through safe and healthful working conditions thereby assuring the conservation of valuable manpower resources and prevention of loss or damage to lives and properties consistent with national development goals, and with the State's commitment to the total development of every worker as a complete human being.

Upholding the above provisions while being diligent with the above duties and responsibilities, we realize that provision of water to employees is one of the ways to promote a healthy lifestyle especially those in the office with limited time to buy water outside the office. Thus, this project.
