# I.BACKGROUND

Pursuant to R.A. No. 7160 otherwise known as the Local Government Code of 1991 particularly Section 444(b)(1) provides that the Chief Executive shall exercise general supervision and control over all programs, projects, services, and activities of the local government.

In the City Government of San Fernando, Pampanga, the City Market Operations Division (CMOD), is mandated to carry out the following responsibilities;

- Responsible for the administration and supervision of the two (2) Public Markets including the duties, functions and assignments of all Market Personnel;
- Responsible for the implementation and administration of market rules and regulations;
- Responsible for the supervision and monitoring of market daily collections both in the Old and New Public Market (market fees, entrance fees, parking fees and rental of stalls;
- Responsible for monitoring orderliness and cleanliness in the market premises in the Old and New Public Market.

In addition, Chapter XII, Section 1 of the 2017 Revised Revenue Code and Market Code of the City of San Fernando, Pampanga states that;

Section 1. Allocation of Collected Market Rental Fees and Charges – After deducting the statutory or contractual obligation, a minimum of twenty (20%) percent of the net income of the City owned public market shall be reserved and set aside for the maintenance and improvement of the market and for market personnel development. The reserved amount shall accrue to the Capital and Management Development Fund of the City Government.

In addition to the above responsibilities, our office also functions as the secretariat of the Market Committee and the Local Price Coordinating Council of the City of San Fernando (P) and other Committees and Technical working groups in connection to the public markets, as secretariat we are in charge in the preparation of all logistics needed during the meetings. In lieu, the office is proposing for the procurement of portable speakers which will be essential during the conduct of meetings.

# **II. BUDGETARY REQUIREMENT**

The Budgetary Requirement for the Supply and Delivery of Portable Wireless Speakers to be used by the City Market Operations Division, City of San Fernando, Pampanga is included in the PPMP with Ref. No. 2024-2981 and already included in the Annual Procurement Plan (APP) of the City Government, which is in the amount of One Hundred Thirty one Thousand Two Hundred Pesos only (Php 131,200.00)

# **III.OBJECTIVES**

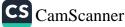

- 2. For the Office to have its own set of Portable Speakers which will be used during meetings with vendors in the Public Markets;
- 3. To ensure that the office can facilitate meetings the market with a good audio equipment for that will make meetings more conducive both vendors and facilitators.
- 4. To have good audio quality helps ensure that all participants, especially those remote, can contribute effectively. This fosters better collaboration and more productive meetings.

- b. Procurement Process
  - 1. For the End- user, ensure the completion of the documents in order to proceed with the procurement process.
  - For the supplier/ provider, ensure the completeness of the documents being required by the Bids and Awards Committee (BAC) for the procurement process on- time based on the procurement schedule including this TOR duly signed by the end- user and conformed by the supplier/ provider.
  - 3. If the procurement process reaches the ensuing year, observe that the allowed delivery is only up to what is stipulated in the contract.
  - 4. For the End-User, present clearly this TOR during the Pre-Bid Conference for the information of the prospective bidder/s (for Competitive/ Public Bidding/ Public Bidding) and present by the Buyer with the assistance of the End-User (for Alternative Methods of Procurement).
  - 5. Ensure that there are readily- available supplies upon submission of Request for Quotation (RFQ)/ Bid since delivery is anticipated upon issuance of PO/ Contract.

- Comply with the provisions of the Procurement Law regardless of the mode of procurement, whether Competitive/ Public Bidding or the use of Alternative Methods of Procurement.
- c. Delivery/ Implementation period
  - 1. Strictly observe the "No Purchase Order (PO)/ Contracts, No Delivery" Policy and comply with the delivery period.
  - 2. The Delivery Period shall be Fifteen (15) days upon issuance of Notice to Proceed.
  - 3. During the delivery, strictly follow the provisions enumerated in the Terms and Condition of the PO/ Contract including the Delivery Schedule, Penalty, among others.
  - 4. In case there is a change in the Delivery Schedule and specifications, the End- user through the Procurement Officer shall coordinate with the CGSO- Procurement Management Division (PMD) for the latter to advise the supplier/ contractor regarding the concern.
  - 5. Coordination with the supplier/ contractor shall be the function of the CGSO- PMD as its mandate.
- d. Inspection and Acceptance
  - 1. The CGSO-PSMD shall inspect and accept the delivery.
  - 2. The supplier/contractor shall present the PO and issue Sales Invoice.
  - 3. The CGSO- PSMD shall prepare the corresponding Inspection and Acceptance Report/s.

Such documents will be used to notify the concerned offices on the delivery such as the City Accountant's Office (CAccO) and Commission on Audit (COA) to include the same in the Payables.

#### V.DELIVERABLES BY THE SUPPLIER/ CONTRACTOR AND THE CITY GOVERNMENT

The deliverables of the supplier/ contractor shall be as follows:

- a. Provide the quantity of items being required by the project/ program; and
- b. Strictly follow the specifications of requirements based on the item description and specification.
- c. The contractor/bidder must provide a minimum of 12 months warranty on the items delivered.

The deliverables of the City Government shall be as follows:

- a. On-time payment of the supplier/ contractor i.e., 15 days after delivery
- b. End- user shall monitor the delivery of requirements.

- c. The Procurement Officer shall assist in the monitoring, delivery and on- time payment of the supplier.
- d. Provide necessary and readily- available documents such as during the conduct of post- audit.
- e. Evaluate the performance of the supplier/ contractor and in case there is a violation to the Contract/ Agreement, prepare a Verified Report.
