**Invitation to Bid for the Contract of Service for the Repair and Maintenance of Parks and Greenbelts (Jose Abad Santos Avenue (JASA), Tourism Road, Civic Center, Town Center Esplanade and Central Materials Recovery Facility for 2nd Semester of 2024 in the City of San Fernando, Pampanga)**

1. The City Government of San Fernando, Pampanga, through the **General Fund 2024** intends to apply the sum of **ONE MILLION NINE HUNDRED NINETY-FOUR THOUSAND TWO HUNDRED FORTY PESOS ONLY (P1,994,240.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Contract of Service for the Repair and Maintenance of Parks and Greenbelts (Jose Abad Santos Avenue (JASA), Tourism Road, Civic Center, Town Center Esplanade and Central Materials Recovery Facility for 2nd Semester of 2024 in the City of San Fernando, Pampanga / 2024-07-01205** consisting of **Five (5) lots**, to wit:

**Lot 1 – Jose Abad Santos Avenue (JASA) with an ABC of P308,600.00**

**Lot 2 – Tourism Road with an ABC of P402,600.00**

**Lot 3 – Civic Center with an ABC of P463,500.00**

**Lot 4 – Town Center Esplanade with an ABC of P530,340.00**

**Lot 5 – Central Materials Recovery Facility with an ABC of P289,200.00**

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The City Government of San Fernando, Pampanga now invites bids for the above Procurement Project. Delivery of the Goods is required within **Twenty (20) days for Lot 1, 2, 3 and 5 Thirty (30) days for Lot 4** upon receipt of Notice to Proceed (NTP). Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from City Government of San Fernando, Pampanga and inspect the Bidding Documents at the address given below during 8:00 a.m. to 7:00 p.m.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **AUGUST 05, 2024 (MONDAY) until 1:00 p.m. of AUGUST 27, 2024 (TUESDAY) except FRIDAYS (due to the Implementation of the Four-Day Compressed Workweek Office-Based Transactions) at CGSO Building, City Civic Center, Alasas, City of San Fernando, Pampanga** and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB in the following amounts:

**LOT 1: FIVE HUNDRED PESOS ONLY (P500.00);**

**LOT 2: FIVE HUNDRED PESOS ONLY (P500.00)**

**LOT 3: FIVE HUNDRED PESOS ONLY (P500.00)**

**LOT 4: ONE THOUSAND PESOS ONLY (P1,000.00)**

**LOT 5: FIVE HUNDRED PESOS ONLY (P500.00)**

The Procuring Entity shall allow the bidder to present its proof of payment for the fees that will be presented in person.

6. The City Government of San Fernando, Pampanga will hold a Pre-Bid Conference on **AUGUST 13, 2024 (TUESDAY) 2:30 p.m.** at **Levi Panlilio, Conference Room, City Hall, Sto. Rosario, City of San Fernando, Pampanga** and shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission on or before **1:00 p.m. of AUGUST 27, 2024 (TUESDAY) at Levi Panlilio, Conference Room, City Hall, Sto. Rosario, City of San Fernando, Pampanga.** Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14.**

9. Bid opening shall be on **AUGUST 27, 2024 (TUESDAY) 2:00 p.m. at Levi Panlilio, Conference Room, City Hall, Sto. Rosario, City of San Fernando, Pampanga.** Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The City Government of San Fernando, Pampanga reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
