I. BACKGROUND

In its role in the organization under the Public Governance System, the Office of the City Vice Mayor aims for a participatory governance. Thus, the Office of the City Vice Mayor conducts several consultative and Legislative meetings every month with various stakeholders from different barangays.

The meetings are instrumental in translating public sentiments and provide mechanisms for information and consultations which are pivotal to the attainment of a dynamic legislature.

II. OBJECTIVE

To provide packed/buffet/catered meals/water/coffee for invitees, guest and participants of the consultative and legislative meetings.


III. SCOPE OF SERVICES

 - Provide payment upon the completion of the service and appropriate billing documents


