TERMS OF REFERENCE

Supply and Delivery of Zoll AED Pads and Zoll Lithium Battery to be used for the Health Emergency Management Staff (HEMS) Unit of the City Health Office for 2025 in the City of San Fernando, Pampanga

I. Background

Access to good quality, affordable, and appropriate health products is indispensable to advance universal health coverage, address health emergencies, and promote healthier populations.

Without medical equipment/devices, common medical procedures would not be possible. Medical devices are used in many diverse settings, for example, by laypersons at home, by emergency medical staff and clinicians, by opticians and dentists, and by healthcare professionals in advanced medical facilities, for prevention and screening and in palliative care. Such health technologies are used to diagnose illness, monitor treatments, assist disabled people and intervene and treat illnesses, both acute and chronic.

Today, there are an estimated 2 million different kinds of medical devices on the world market, categorized into more than 7000 generic devices groups.

A medical device can be any instrument, apparatus, implement, machine, appliance, implant, reagent for in vitro use, software, material, or another similar or related article, intended by the manufacturer to be used, alone or in combination for a medical purpose.

II. Budgetary Requirement

The budgetary requirement for the Supply and Delivery of Zoll AED Pads and Zoll Lithium Battery to be used for the Health Emergency Management Staff (HEMS) Unit of the City Health Office for 2025 in the City of San Fernando, Pampanga is included in the PPMP with **Reference no. 2025-1250** and already included in the Annual Procurement Plan of the City Government, which is in the amount of **TWO HUNDRED FIFTY-FOUR THOUSAND NINE HUNDRED NINETY PESOS (P 254,990.00).**

III. Objective

The objectives of the Supply and Delivery of Zoll AED Pads and Zoll Lithium Battery to be used for the Health Emergency Management Staff (HEMS) Unit of the City Health Office for 2025 in the City of San Fernando, Pampanga are as follows:

- a. Essential to prevent, diagnose, treat and rehabilitate illnesses and diseases in a safe and effective way.
- b. Makes it easier for caregivers to perform their duties. This equipment makes it easier to monitor and care for their patients.

IV. Terms and conditions

During the procuring process and delivery/implementation of the contract, the end-user and the supplier/contractor shall:

A. Specifications/ Schedule of Requirements

The expiration date of the supplies requested should be at least **TWO (2) YEARS OR TWENTY FOUR (24) MONTHS** upon delivery and should be in good condition and packaging. In case the expiration date of the supply does not meet the requirement needed, the supplier should replace the supply at least 3 months before its expiration date.

The supplier must coordinate with HEMS Unit's Medical Coordinator or Nurse Coordinator prior to the procurement of medical supplies. Approval from the HEMS Medical/Nurse Coordinator should be secured. The end-user has the right to refuse the medical supplies if it's not in accordance with the acceptable standards.

b. Procurement Process

- 1. For the End-user, ensure the completion of the documents in order to proceed with the procurement process.
- 2. For the supplier/ provider, ensure the completeness of the documents being required by the Bids and Awards Committee (BAC) for the procurement process on-time based on the procurement schedule including this TOR duly signed by the end-user and confirmed by the supplier/provider.
- 3. If the procurement process reaches the ensuing year, observe that the allowed delivery is only up to what is stipulated in the contract.

- 4. For the End-user, present clearly this TOR during the Pre-bid Conference for the information of the prospective bidder/s for (Competitive/ Public Bidding), and present by the Buyer with the assistance of the End-user (for Alternative Methods of Procurement).
- 5. Ensure that there are readily-available supplies upon admission of Request for Quotation (RFQ)/ Bid since delivery is anticipated upon issuance of PO/Contract.
- 6. Comply with the provisions of the Procurement Law regardless of the mode of procurement, whether Competitive/Public Bidding or the use of Alternative Methods of Procurement.

C. Delivery/ Implementation Period

- 1. Strictly observe the "No Purchase Order (PO)/ Contracts, No Delivery" Policy and comply with the delivery period.
- 2. The Delivery period shall be on March 2025.
- 3. During the delivery, strictly follow the provisions enumerated in the Terms and Condition of the PO/Contract including the Delivery, Schedule, Penalty, among others.
- 4. In case there is a change in the Delivery Schedule and specifications, the End user through the Procurement Officer shall coordinate with the CGSO-Procurement Management Division (PMD) for the latter to advise the supplier/ contractor regarding the concern.
- 5. Coordination with the supplier / contractor shall be the function of the CGSO-PMD as its mandate.
- 6. For onsite delivery, ensure the coordination with the Inspector from the CGSO- Property and Supply Management Division (PSMD) for the inspection of the delivery In terms of quantity and quality of Medical Equipment and to immediately notify the supplier/ contractor in case of any concerns before the acceptance.

D. Inspection and Acceptance

- 1. The CGSO- PSMD shall inspect and accept the delivery.
- 2. The supplier/contractor shall present the PO and issue Sales Invoice.
- 3. The CGSO- PSMD shall prepare the corresponding Inspection and Acceptance Report/s.

Such documents will be used in notifying the concerned offices on the delivery such as the City Accountant's Office (CACCO) and Commission on Audit (COA) to include the same in the Payables.

V. Deliverables by the supplier/contractor and the City Government

The deliverables of the supplier/ contractor shall be as follows

- a. Provide the quantity/quality of medical equipment being required; and
- b. Strictly follow the specifications and timely provision of requirements based on the delivery schedule.

The deliverables of the City Government shall be as follows:

- a. On- time payment of the supplier/ contractor- i.e 15 days after delivery regardless if the delivery is per month or Ordering Agreement.
- b. End user shall monitor the delivery of requirements.

- c. Procurement Officer shall assist in the monitoring, delivery and on-time payment of the supplier.
- d. Provide the necessary and readily-available documents such as during the conduct of post audit.
- e. Evaluate the performance of the supplier/contractor in case there is a violation to the Contract/ Agreement, prepare a verified report.
