### **RATIONALE**

Marriage a formal union, social and legal compact between two people that unites their lives on a legal, financial, and emotional level. Typically, the contractual marriage agreement means that the couple will be bound by one other's legal duties for the rest of their lives and to provide security for children.

In fact, an **Executive Order No.209, Series 1987 "The Family Code of the Philippines"** Chapter 1, Article 1, that marriage is a special contract of permanent union between a man and a woman entered into in accordance with law for the establishment of conjugal and family life. It is the foundation of the family and an inviolable social institution whose nature, consequences, and incidents are governed by law and not subject to stipulation, except that marriage settlements may fix the property relations during the marriage within the limits provided by this Code.

This program will provide assistance for unwed couples who are incapable in applying for their marriage license & unable to manage certain amount for the wedding ceremony particularly for indigent couples who wish for their legitimate life-long public commitment.

Therefore, as basic and essential building blocks of societies, families have a crucial role in social development. They bear the primary responsibility for the education and socialization of children as well as instilling values of citizenship and provide practical & emotional support for its members.

- ✚ to motivate couples that they are one of the vital foundations of the city and reliable partner of the city government for primary social relationships and values that helps people make the right decisions in life.
