TERMS OF REFERENCE

SUPPLY AND DELIVERY OF MEALS TO BE SERVED FOR THE CHILD HEALTH PROGRAM: INTEGRATED MANAGEMENT OF CHILDHOOD ILLNESSES TRAINING OF THE CITY HEALTH OFFICE FOR 2025 IN THE CITY OF SAN FERNANDO, PAMPANGA

I. BACKGROUND

According to the World Health Organization (WHO), Integrated Management of Childhood Illness (IMCI) is a systematic approach to children's health which focuses on the whole child. This means focusing not only on curative care but also on the prevention of disease.

Philippines has one of the highest Infant Mortality Rate and Under Five Mortality Rate compared to neighboring countries in East Asia. One child dies for every 4.4 percent of deaths among all ages. Pneumonia, diarrhea, measles and malnutrition or combinations of these conditions are the most common causes of child deaths. Although these conditions are preventable, they continue to be the top health problems among children.

Annually, the city procures medicines, given to children diagnosed with childhood illnesses such as diarrhea, pneumonia and upper respiratory tract infections to prevent morbidity and mortality of the said childhood illnesses.

There are already existing Expanded Program on Immunization (EPI), Malnutrition Prevention and Control programs that are already in place to address these health problems. However, these are vertical programs that have its own set of operational guidelines at different stages of implementation.

Sustaining effective treatment is just a part in the management of childhood illnesses. Major focus should be on the prevention of getting ill. Hence, a regular health education lectures and activities to the barangay, observing basic infection control protocol is needed to attain this goal. Through this regular health educations, Fernandinos will be more knowledgeable about disease prevention.

II. BUDGETARY REQUIREMENT

The budgetary requirement for the **SUPPLY AND DELIVERY OF MEALS TO BE SERVED FOR THE CHILD HEALTH PROGRAM: INTEGRATED MANAGEMENT OF CHILDHOOD ILLNESSES TRAINING OF THE CITY HEALTH OFFICE FOR 2025 IN THE CITY OF SAN FERNANDO, PAMPANGA** is included in the PPMP with the **Ref. No. 2025-835** and is already included in the Annual Procurement Plan (APP) of the City Government, which is in the amount **SIXTY-TWO THOUSAND FIVE HUNDRED FIFTY PESOS (62,550.00)**

III. OBJECTIVES

The objectives of the **SUPPLY AND DELIVERY OF MEALS TO BE SERVED FOR THE CHILD HEALTH PROGRAM: INTEGRATED MANAGEMENT OF CHILDHOOD ILLNESSES TRAINING OF THE CITY HEALTH OFFICE FOR 2025 IN THE CITY OF SAN FERNANDO, PAMPANGA** are as follows:

- To sustain the annual requirements through procurement of medicines for the Control of Acute Respiratory Infection (CARI) and Control of Diarrheal Diseases (CDD) based on the cases seen from the previous year.
- To contribute to the reduction of infant and child morbidity and mortality towards the attainment of the Sustainable Development Goal (SDG) No. 3- Good Health and Well Being, and SDG No. 6- Clean and Water Sanitation.

- To achieve our goal in reducing the prevalence of Soil Transmitted Helminths in the country to less than 20% by 2025.

IV. COVERAGE/SERVICES

- According to the constituency perspective, the City Health Office strategic objective is to reduce infant and child morbidity and mortality among under 5 years old.

V. TERMS AND CONDITIONS

b. Procurement Process

1. For the End- user, ensure the completion of the documents in order to proceed with the procurement process.
2. For the supplier/ provider, ensure the completeness of the documents being required by the Bids and Awards Committee (BAC) for the procurement process on- time based on the procurement schedule including this TOR duly signed by the end- user and confirmed by the supplier/ provider.
3. If the procurement process reaches the ensuing year, observe that the allowed delivery is only up to what is stipulated in the contract.
4. For the End- user, present clearly this TOR during the Pre- Bid Conference for the information of the prospective bidder/s (for Competitive/ Public Bidding), and present by the Buyer with the assistance of the End- user (for Alternative Methods of Procurement).
5. Ensure that there are readily- available supplies upon submission of Request for Quotation (RFQ)/ Bid since delivery is anticipated upon issuance of PO/ Contract.
6. Comply with the provisions of the Procurement Law regardless of the mode of procurement, whether Competitive/ Public Bidding or the use of Alternative Methods of Procurement.

c. Delivery/ Implementation period

1. Strictly observe the “No Purchase Order (PO)/ Contracts, No Delivery” Policy and comply with the delivery period.
2. The Delivery Period shall be on **JULY 2025**.
3. During the delivery, strictly follow the provisions enumerated in the Terms and Condition of the PO/ Contract including the Delivery Schedule, Penalty, among others.
4. In case there is a change in the Delivery Schedule and specifications, the End- user through the Procurement Officer shall coordinate with the CGSO- Procurement Management Division (PMD) for the latter to advise the supplier/ contractor regarding the concern.
5. Coordination with the supplier/ contractor shall be the function of the CGSO- PMD as its mandate.
6. For onsite delivery, ensure the coordination with the Inspector from the CGSO- Property and Supply Management Division (PSMD) for the inspection of the delivery in terms of quantity and quality of meals and to immediately notify the supplier/ contractor in case of any concerns before the acceptance.

d. Inspection and Acceptance

1. The End- user shall accept the delivery with the (1) delivery receipts, and submit immediately to the Inspector or CGSO- PSMD together with the (2) attendance sheet/s as part of the utilization where the quantity of the delivery is the same as the number of attendees and photo documentation of the delivery.

Such documents will be used in notifying the concerned offices on the delivery such as the City Accountant's Office (CAccO) and Commission on Audit (COA) to include the same in the Payables.

VI. DELIVERABLES BY THE SUPPLIER/ CONTRACTOR AND THE CITY GOVERNMENT

The deliverables of the supplier/ contractor shall be as follows:

- a. Provide the quantity of meals being required by the project/ program; and
- b. Strictly follow the specifications and timely provision of requirements based on the delivery schedule.

The deliverables of the City Government shall be as follows:

- a. On- time payment of the supplier/ contractor i.e., 15 days after delivery regardless if the delivery is per month or Ordering Agreement.
- b. End- user shall monitor the delivery of requirements.
- c. The Procurement Officer shall assist in the monitoring, delivery and on- time payment of the supplier.
- d. Provide necessary and readily- available documents such as during the conduct of post-audit.
- e. Evaluate the performance of the supplier/ contractor and in case there is a violation to the Contract/ Agreement, prepare a Verified Report.
