### TERMS OF REFERENCE

PRINTING AND DELIVERY OF TARPAULIN TO BE USED FOR THE ECCD EARLY REGISTRATION (BATCH1) FOR THE YEAR 2025 IN THE CITY OF CAN TERMANDO PAMPANGA

#### I. BACKGROUND

Pursuant to Section 2 of the Republic Act No. 10410, known as the Early Years Act (EYA) of 2013, the state shall institutionalize a National System for Early Childhood Care and Development (ECCD) that is comprehensive, integrative, and sustainable, that involves multi-sectoral and interagency collaboration at the national and local levels among government; among service providers, families and communities, and among the public and private sectors, non-government organizations, professional associations and academic institutions;

Republic Act 10410, or the Early Years Act of 2013 declares as a policy that the State shall institutionalize a National System for Early Childhood Care and Development (ECCD) that is comprehensive, integrative, and sustainable, that involves multisectoral and interagency collaboration at the national and local levels among government; among service providers, families and communities, and among public and private sectors, non-government organizations; professional associations and academic institutions.

Section 3 on Republic Act cites the objective of the National ECCD System which is to improve the quality standards of public and private ECCD program through, but not limited to, a registration and credential system for ECCD service providers and facilities. The City of San Fernando, Pampanga aims to strengthen ECCD programs, generate awareness, interest and understanding on ECCD through advocacy, and social mobilization.

### II. BUDGETARY REQUIREMENT
