The Bidding Documents will be available to all interested bidders at the City General Services Office, Motorpool Compound, New Public Market, City of San Fernando, Pampanga, upon payment of a non-refundable amount of **TEN THOUSAND PESOS ONLY (P10,000.00).**

Bid tenders or offers must be accompanied by bidder's bond in cash or manager's check in an amount equivalent to 100% of the total amount of bid. Bid bonds from non-winning bidders shall be returned immediately after the opening of bids, while bid bonds from winning bidders shall form part of the payment.

The winning bidder is given only ten (10) days to effect the removal of the sold articles from the motorpool compound upon the award of bid. In case of non-removal, a storage fee of **FIVE HUNDRED PESOS (P500.00)** per item per calendar day shall be charged to the winning bidder.

The City Government of San Fernando, Pampanga, reserves the right to reject any or all bids, waive any minor defects therein and accept the offer most advantageous to it.
